TVA's 2019 Integrated Resource Plan

This month's chapter program may provide a glimpse into the future as to how electric usage may be impacted on you or your clients. How will the Tennessee Valley Authority be addressing consumer usage for integrating renewables, cogeneration, energy efficiency, or the wise usage of electricity... while still following its overall mission for the Valley?

Hunter Hydras has held various roles at the Tennessee Valley Authority (TVA) in Clean & Renewable Energy, Environmental Policy & Regulatory Affairs and now in Enterprise Planning. For the past two years, Mr. Hydras was the project manager for TVA's 2019 IRP, leading internal modeling and strategy teams as well as supporting stakeholder engagement to define how TVA and local power companies will meet the Tennessee Valley's future energy needs. He is currently the Senior Manager of Portfolio Analytics, a group responsible for the economic analysis to value capital investments, commodity transactions, renewable procurement, and strategic projects. Mr. Hydras holds a B.S. degree in Environmental Science from Middle Tennessee State University and a M.S. in Engineering Management for the University of Tennessee at Chattanooga.

The Tennessee Valley Authority's 2019 Integrated Resource Plan (IRP), approved by the TVA Board in August 2019, is a long-term plan that provides direction on how TVA can best meet future demand for power. It shapes how TVA will provide low-cost, reliable and clean electricity; support environmental stewardship; and foster economic development in the Tennessee Valley for the next 20 years. The plan is a crucial element for TVA's success in a constantly changing business and regulatory environment, and it will better equip TVA to meet many of the challenges facing the electric utility industry in the coming years to benefit the Valley. The IRP will enhance TVA's ability to create a more flexible powergeneration system that can successfully integrate increasing amounts of renewable energy sources and distributed energy resources (DER) while ensuring reliability. The IRP also will inform TVA's next Long-Range Financial Plan.
